Minutes of IAB Meeting – Discussion & Decisions

Item No.	Agenda	Discussion & Decision Taken
01	Welcome Address & Introduction	Welcome address and opening remarks were given by Dr. Mrunal A. Deshpande. The agenda of the meeting was presented. Introduction of Industry Advisory Board (IAB) industry representatives was carried out.
02	Student-Industry Collaboration	Discussion was held on strengthening student-industry collaboration through Project-Based Learning (PBL), internship projects, and industry-defined problem statements. Industry members encouraged active student participation.
03	Syllabus Improvement	The need to revise and update the syllabus as per recent industrial trends was discussed, with emphasis on Electric Vehicles, Automation, and advanced electrical technologies.
04	Practical-Oriented Syllabus	It was discussed and agreed to include more practical-oriented and application-based components in the syllabus to improve students' hands-on skills and industry readiness.
05	Sponsored Laboratory	Mr. Bhushan Navarkar Sir expressed readiness to support sponsorship of an EV-related laboratory. The proposal was appreciated and further feasibility and requirements will be explored.
06	EV & Automation Opportunities	Discussion was held on the importance of Electric Vehicles and Automation, career opportunities, and academic facilities. Mr. Shrikrishna Kshirsagar Sir highlighted the growing demand for skills in industrial automation, control systems, and smart manufacturing, and suggested curriculum alignment with industry practices.
07	Guest Lectures & Research Collaboration	Discussion was carried out regarding guest lectures, industry visits, and co-teaching by industry experts. Industry members expressed willingness to support research activities and accept new research problem statements.
08	Vote of Thanks	The meeting was concluded with a vote of thanks to all the members for their valuable time, guidance, and support.
